SUB: BSG RULE NO. 68 – THE STATE COMMISSIONERS – ROLE & RESPONSIBILITTY - REG

Dear Sir/Madam,

This is to inform you that as per amended rules No. 68 of the rules book of the Bharat Scouts and Guides, there is a provision of four State Commissioners of Cub, Scout, Rover and Adult Resources and four State Commissioners of Bulbul, Guide, Ranger and Adult Resources.

The function of the State Commissioner of Cub/Scout/Rover/Adult Resources and the State Commissioner of Bulbul/Guide/Ranger/Adult Resources as the head of their respective section and stated in rule no. (68.3.1) upto (68.3.5). Similarly, as per rules no. 75.2.4 the State Training Commissioner shall recommend to the concerned State Commissioner of Adult Resource eligible persons for appointment as members of the State Training Team in the State. Rules no. 75.2.9 states that the State Training Commissioner shall recommend to Dy. Directors (Leader Training) for award of H.W.B. Parchments and Beads/Pins to Scouters and Guiders who complete the requirements on the recommendations of the concerned State Commissioner of Adult Resource. Rule No. 83.2 and 85 also states the role of State Commissioner (Adult Resources).

State Associations are also requested to refer APRO Part-I chapter – III of the amended rules No. 28.2.6 pertaining to Warrant of Appointment to be issued under the signatures of State Chief Commissioner and concerned State Commissioner. Similarly as per rules no. 40 of APRO part – I, it is stated that the warrant shall be renewed by the same authority who has issued the warrant following the same procedure prescribed for issue of warrant as such and rules no. 41 states that warrants issued by the State Chief Commissioner may be withdrawn, for reasons to be given in writing by the State Chief Commissioner in consultation with the State Commissioner concerned.
